- 1. Tim opened the meeting with self-introductions, thanking all for attending and welcoming Annette Chapman as a new member of the group.
- 2. **St Barnabas Lincolnshire Hospice:** Ruth O'Melia, Community Liaison Manager for St Barnabas gave a short and very interesting presentation in relation to the work of the Hospice, dispelling some commonly held views with regard to the work of the hospice and their raison d'etre in the process. It was agreed that a copy of the fuller presentation would be circulated to all PPG members, and that appropriate links would be made on then practice website and tickertape video screen.
- 3. Notes of the Meeting of 7 April 2015 and matters arising from them:

The notes had been circulated in advance of the meeting and the following points were updated:

- d. **Carers Support Partnership:** Don had contacted Clive Yates, who confirmed that he would be able to attend the PPG June meeting to make a presentation.
- e. **Carers:** It was confirmed that there was now a new and comprehensive section on the website that covered most of the issues faced, or of interest to, those in the caring role. It was also confirmed that the practice had a robust process in place for identifying and assisting patients in similar roles.

### 4. PPG Awareness Week:

It had previously been agreed that the practice would host an awareness day for the PPG on Friday 5 June, and it was decided that this would take the format of an opportunity to promote both the Friends and Family Test, and also provide some information in relation to the work of the PPG and – in the process – interest new members if possible It was felt that this would be best served through concentrating on 2 specific times of the day – 0930 to 1130, and 1400 to 1530, as these tended to be the busiest times.
